Dr. Ana: We need to be aware that there is a lot of mind control already going on because this technology is so far advanced already.

Sarah: Delgado's view is we don't have rights. WEF is talking about how it is an illusion that we even have rights. God given rights is something they don't believe in [since Harari says God is a fairy tale —my comment].

Todd: Yes.

Sarah: And you are saying legally that is already in place. Todd: Yes, the pretext, the COVID pandemic created the opportunity for the World Powers to call in suspension of all civil and human rights, political, civil, constitution human rights are suspended. Human rights are suspended by public health emergency of international concern, and when those words are uttered in any country you are under medical martial law and that is where we are today and have been since March 13, 2020 and they are never coming back because they have transformed most of humanity into a new species.

Todd: And each one is cataloged and stored with IBM with a barcode on each and everyone of these pathogens and the things that they create.

Lisa: The barcodes are used a couple ways: There are IP addresses to the majority of all these ingredients that have IP addresses to IBM and to MAC. - IBM was the first supercomputer that the DOE (Dept of Energy) installed back in 1969 and that was their data collection network. Todd: So these bugs (pathogens) that they made transmissible had IP addresses and turned our bodies into an accessible wireless body area network.- The gene sequence for the spike protein states it is for SARS CoV-2, so it is an installation system that collaborates along with these synthetic bacteria. All of this was for transforming us into a new species or killing us. I doubt they cared which would happen. - This installation software by virtue of contagious disease, by getting everyone sick with COVID gave the prelude to the hardware solution which was the Moderna, Pfizer, and Johnson and Johnson shots.

Lisa: And we cannot underestimate what the seasonal flu shots contribute to this. At the end of the assembly all the shots are meant to be a part of the huge puzzle that make it all work. [20:12]

Todd: This is the point I want to get to, the Transnational Repression from our government. So they install all this stuff and then they went to a war on terror and now it is a war on viruses that they can use to control us. And in this document they say they might have to look out for the bad guys and they are TARGETED INDIVIDUALS. This is a program by our government to Track and Trace among other things targeted individuals and that is how they have us down to our genetic code.

Lisa: The PTB are literally turning humanity into the bioweapons that they say they are protecting us from. They are creating the Targeted Individual full of these viruses and this bacteria to be able to harness the legislation ruling and the control.

Todd: I found in the Ministry of Defense a Human Augmentation Guide that the Germans and Brits got together to do this and they talk about super soldiers going forward. So they finally ask about rights for these people. There are no rights. We are a shadow property to them.

Lisa: The PTB want a conversion and mutation and altering of how biologically we create our cellular energy. So they are after that. It is not just about killing us. It is about the transformation and converting into a supply and demand of illnesses and diseases and shedding factories to omit gases that are sustainable for them but not for us. [sounds off-planet to me—my comment] It is a real transformation.

Todd: By virtue of this installation of the hardware, these shots, they have reprogrammed people's bodies to become factories for spike proteins, and prions, which make you lose your mind.

Lisa: In 2003 we discovered that in the Federal Register there were 15 inventors on the patent and they were all employed by the FDA and the CDC. These people are

employees of our government and they are programmed with a role and responsibility to go in and perform. In our case it was Robert Vios and we were thrown out of the Supreme Court. The issue boiled down to the law according to the Supreme Court Molecular Pathology versus genetic, states that use mRNA to effect gene modification means that the patent holders own the synthetic product. People were programmed to produce the spike protein now. That is a genetic modification so you are saying the patent holder is the US government, its Health and Human Services. And, they own the factories called synbio people that are producing spike proteins.

Lisa: I think that is how we can look at it and WHO is the overlord of all this because they have a product line and they are products, because they are all for sale. And they have exclusive rights and they have produced Vero Cells. And the Vero E 6 cells were used to traffic that spike protein, Sars CoV soluble solution in 2003. So these Vero E 6 cells are in almost all of the CDC recommended childhood vaccines.

Todd: How many recommended childhood vaccines are there?

Lisa: There are 17 officially, but by the time children are 18 they have almost a 100 vaccines.

Todd: Let's make sure everyone understands this. If your child is in a public school the recommended vaccines become required vaccines. And there are 17 of them that transform their bodies into a slave species owned by our government.

Lisa: The CDC and WHO have announced a partnership and it is now called the Surveillance Data Collection Network. Who is doing the surveillance? It is the bacteria

and medicines that are being used [in the person's body?] to do the surveillance.

Todd: If you don't believe that they have the ability to access your body go to Inpersona.com and you can download a program to use the information coming out of your body to mine crypto currency. That shows the technology is already here. They have already harnessed people. They are already accessing the intelligence from the inside. Sarah: Some of the engineers who are working on this tech are coming out as whistle blowers. It is bad that so many of these people are compartmentalized because it is like we have

humans that are helping to create our own slavery and we are funding our own slavery.



Dr. Ana: We want to hear your overview of this program so take it away.

Richard: I am going to cover some of the basics of the targeting program, could call it Targeting 101 class. Richard has a B.S. in Aerospace Engineering and an M.S. in Mechanical Engineering and worked for NASA and worked 20+ years in the energy industry. So the basics of the program is CIA's, MK-Ultra and FBI's Cointel Pro. These two programs were combined in such a way as to create a program that NEUTRALIZES people using emotional, psychological and physical stress and covert means. That is their goal.

What does it take to get someone to shut down without having to kill them or imprison them. What can be done to NEUTRALIZE someone using emotional, psychological, and physical stress. That is the purpose of this program.

Everyone's name is put into a list that's called the terror screening database, [Executive Order HSPD-6] done in 2003 under President George Bush, Jr. Everybody who is listening to this program (in the US) is being tracked with microwave pulses from Lockheed and Boeing GPS satellites. Your exact location within half-an-inch is known 24/7 by Shriever Space Force Base in Colorado Springs. That tracking frequency can also be used as a weapon if it's



turned up. So what do they do with the tracking location in your head?

They track the information in your head, they relay it to satellites that are in geosynchronous orbit to Shriever Space Force Base and then forward that signal to a cell tower and it's used and that location data is used to send subliminal messages to your head 24/7. This bombarding the population with subliminal messages was called Mass Formation Psychosis by a person interviewed by Joe Rogan. What they don't know is this is the technology that is being used to trigger it. They are bombarding the entire population with subliminal messages 24/7. How do I know if I'm a Targeted Individual?

Do the Ear Cup Test: In a very quiet room cup your ears for 60 seconds. Listen for the microwave "pops," or what we call the microwave popcorn. This is a tracking signal used from cell towers. You can also use a stethoscope placed behind the ear. It is random. This is a backup tracking signal that comes from cell towers. All the cell towers within several miles of you are sending a tracking pulse, these microwave popcorns at your head.

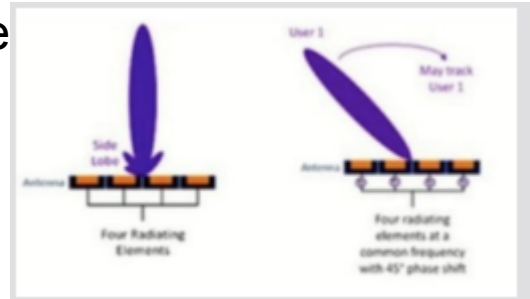
Microwave Burns This is what some of these energy weapons can do. The woman in Arizona has been burned like this more than 20 times. Some of these burns are from satellites and some are from cell towers.



Digital Beamforming using 4 panel antennas on the cell tower. The main lobe has a typical range of 5+ miles and can go thru many buildings to

hit a target. Beam Steering and MIMO allow the antennas to track and hit many targets at the same time by using high-speed pulsing, or different frequencies.

See the purple diagram there where the microwave beam can be controlled and pointed very accurately. So it is less than a half-inch precision anywhere in the world where these cell towers are



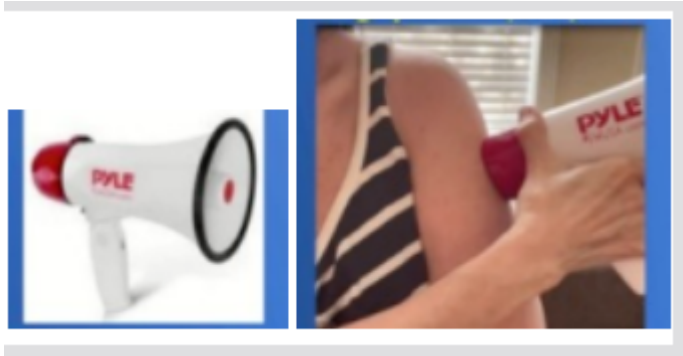
calibrated and located. This is very important. This is one of the best images we've got of one of the operations rooms at Schriever Space Force Base. This is the Joint Interagency Combined Space Operations Center and you can see it takes only a small group of people who can watch and control satellites anywhere in the world. It is a very impressive setup according to Dr. Bill Deagle.



The resume of Sargent Charles Surchay at Schriever AFB in 2017 goes into the discussion of who is responsible for some of these programs. He led 1,300 of the Schriever AFB

employees who were dedicated to operations and nine different weapon systems in orbit and five CPI events which refers to continuous performance improvement. Another resume of John Slaughter identifies as a Space Weapons Officer. We found 30 Space Weapons Officers and they all work at Schriever's AFB.

We recently discovered the megaphone test, a \$15 dollar device that can be bought at Walmart's or like stores and that detects electromagnetic fields in



your body. The megaphone

“shrieks” next to an EM field and there should not be any measurable EM fields in your body. What we have found is that all targeted individuals have these implants. And we have found that 50 percent of the general population has some kind of graphene or nonconsensually implants in their body. It is important we get this to the general public to find out who or what is cooperating to put these illegal implants in people's bodies. It is grossly illegal and we need it shut down. Todd: They discovered that targeted individuals are losing their hair from being followed around by these GPS systems and cell phone network was interfering with their hair follicles.

Sarah: You were talking about the Trump Derangement Syndrome and getting people to fear with COVID and some of us are starting to suspect that the people are mind-controlled, right?

Richard: Yes. Sarah: Because we can't understand why something so obvious, they can't see it. And they are just

being herded. Why is it that others like you and me, none of us are affected by that. Why? What is the difference?

Richard: It is subliminal messaging and it involves the altering of personal beliefs. Someone who trusts the government will be open and receptive to messages along those lines. Somebody who distrusts the government is going to immediately put up a mental block. Even in their subconscious mind they are going to say "I'm not sure that is true." So subliminal messaging over and over and over again, even very simple messages to somebody who is receptive to a statement like "you hate Trump," "you hate Trump," "you hate Trump." If they are open and receptive to that it becomes planted in your subconscious mind. It is very destructive.

Todd: How about "safe and effective?" That explains a lot.

Sarah: Well it is just crazy. The mental construct, because I have had somebody right at the beginning of COVID telling me that their goal is to mess with our mental constructs so that we make the decision ourselves, so that is what they are doing. It makes a lot of sense. It doesn't make sense that all of these people are doing things that are so absurd.

Todd: How do you block it Richard. What do you personally do to keep them out of your head?

Richard: So there is a number of helpful suggestions you can give to your subconscious mind. One of them that I find very powerful is "I will only react to constructive suggestions." The other one might be "I will ignore... I will easily ignore subliminal messages." You just want to block it all out. Tell your subconscious mind don't be open or receptive to anything unless you specify and you can go to some of these websites that recommend subconscious suggestions that are helpful. That's just two examples.

Todd: Well interesting, real quick I was going to say I get these feeds from God. I really do. The reason I know they are not subliminal is because they are always about good things. Do the right thing. Do the good thing, the golden rule things of that nature. So I think that is the way to separate them out. Alright, go ahead.

Sarah: Well I was just going to say the mental constructs I had a psychologist tell me that if it hurts you, you won't do it but they haven't figured out a way to work with your own constructs to think that it helps. We have a control mechanism built into us that if we think it is going to hurt us we won't do it.

Todd/Richard: Yeah.

Dr. Ana Mihalcea: I want to talk about what you have been talking about, about hijacking electricity. This microchip technology exists and we need to understand the mechanisms of injury. I have been a targeted individual. I almost lost my life when I was targeted, so I learned about it from a personal perspective. The mechanisms of injury are manifold, oxidative stress, free radicals, accelerated aging that is happening to all of the nanotechnology in their bodies.

There are people who are being targeted and tortured but there are others that are affected in a way that that is so insidious and it is leading to disease and depression, even suicide. It can be directed energy weapons and this has microwave injury. Extremely low frequencies are being used and we have documented that and in the blood. I'll show more about this. Electromagnetic frequency can also be harmful and therefore there is DNA damage. There is physical torture and I have witnessed torture. People are being attacked by these microwave weapons and the radio frequency meters are just off the chart. There are extreme

headaches and sometimes the genitalia are affected. They are falling over to the side. They can no longer walk in a straight line. Many people have died because they were literally tortured to death.

This is happening to billions and we must understand that with the social credit system and digital ID and identification under the skin, this is the technology for an absolute Orwellian slave state. This is not new. Dr. Hildegard Staninger had documented microchip implants in targeted individuals as early as 2012. One example was a 57-year-old woman talking on the phone (right ear) felt burning-glass needles entering her left ear and a few weeks later continued to have pain and headaches and she was diagnosed with a meningioma. She had it removed and it was advanced nano materials that were tested and an ear canal specimen showed microchips. This gives me clues of what is happening with the shots. There were many metals in the person's body and it is known that these crystals that are nano antenna are using metals to be able to target frequencies. They also found metabolites of styrene, a plastic. The rubbery clots we found in the blood of the vaxed and unvaxed were made from polyamide, so this nylon or silk-like material like a genetically engineered protein from spider silk. So this is used to monitor DNA as a biosensor and these structures form crystals and they work together with the metals for many applications. This research was done by the DOD.

The ear canal specimen of the above study showed graphite. Other materials found in the biosensor mesogen (a compound that has both solid- and liquid-like properties called liquid crystalline state) was silicon, sulfur, and amide polymer that appeared to be an animal-like protein. The meningioma specimen could only be cut with a diamond



saw. It wasn't a meningioma. It was a hydroxyapatite and a protein polymer that was constructed to build a brain chip. Nanotubes, nanospacers, nano rods, nanowires and many other single components are even used to make the nano radio, as used in nano medicine. Many times people are implanted when they have medical procedures or through vaccinations as we have now shown. I have found similar crystalline structures in insulin. So mesogens are liquid crystals that can perform smart functions for smart cities but they are used as a platform as a thin film which is used as a brain chip biosensor. What do these biosensors do?

1. They control and monitor the brain and body function
2. Absolute control and surveillance of all EG functionality
3. Control and monitoring of behavior and it can be remotely modified.
4. V2K. Sending and Receiving of verbal commands.
5. Stimulation of bioelectrical transmissions within the neuron trees of the nerves that can rewire your brain via read and write
6. Remote sensing and surveillance. They can see out of the eye of the targeted individual and have full spectrum camera and it is also used as a digital computer component to the device and could capture visual transmissions as a walking/talking monitoring system. The intrabody area network which hijacks the electricity from our human body to power itself requires something like a cellphone, and then it transmits the data to the satellite by the spider actual telemetry and it's used for dual use applications in the military.

We found polyamide, amide, alcohol, silicone and sulfur in human vaccinated and unvaccinated blood. These were found as chemical components of the brain chip. Silicone

and sulfur were found in the brain chip mesons as well. We found graphite implanted microchips in the blood. These computer chips are giving off MAC addresses. The vaccination technology sheds to the unvaccinated. Biosensors found in blood of unvaccinated send messages to the cloud and they are hijacking the electricity from the blood which is working to create these clump things, rubbery clots. This also modifies human DNA.[1:16]

Quantum dots are a ticking time bomb. They are extremely toxic and there are metals in them, for example cadmium, and they have caused death in animal studies. We know that the quantum dots and microrobots are now in the food supply. They are used as nano sensors. There's smart dust everywhere. The vaccinated blood, a C19 bioweapon is extremely sensitive to 4 hertz, an extremely low frequency (ELF) radiation. 4 hertz is the delta brain wave activity of the subconscious mind and is used by HAARP. This is creating an ambient feeling around the world and it is used to ionize our biosphere and our ionosphere for weather warfare but it has also been used for mind control.

What can ELF frequencies do to human health?

1. They can control human mental functioning
2. They can disrupt cellular metabolism
3. They can suppress the immune system
4. They can genetically modify humans
5. They can influence free radical formation causing inflammation and accelerated aging
6. There is also phenomenon cyclotronic resonance. Dr. Nick Begich has disclosed that HAARP is used as a mind control tool. Tests have discovered that some people who are vaccinated and targeted have 4 hertz brain wave activity in the waking state, a frequency one should experience

when sleeping. Igor Smirnoff, a Russian mind control researcher says it is possible for some “Satan” to inject (intrude) into every computer network, radio, or television broadcast with relative technological ease and without disconnecting cables. One can intercept the radio waves in the ether and then subliminally modulate suggestions into it. If this goes on for a long time, it accumulates in the heads of people and they can eventually be artificially manipulated to do what the perpetrator wants them to do. This is why technology is rightfully feared.

Ted Gunderson, former FBI Chief has testified that tentacles are involved in this stalking and targeting. The military has studied the damage they can do with microwave weapons to the brain and post microwaves can induce stress that may be indicated in neuropathy that people experience. An example is the temperature rise within the head due to the pulsed microwaves and it can cause brain edema. So what can people do?

1. Activated Charcoal has been used for traumatic brain injury and that is what microwave pulsing is inducing, so that has been helpful.
2. EDTA chelation therapy can also be used for detoxification in the treatment of neurotoxicity from the C19 bioweapon that is shedding onto people. EDTA pulls out metal so it is helpful in getting the antenna out but it has also been used for neurotoxicity and EMS radiation poisoning of the brain.
3. Methylene Blue is neuroprotective against mild traumatic brain injury. The methylene blue is an ultraviolet blue dye that has remarkable regenerative abilities for the brain and also global ischemia. It increases the oxygen delivery to the tissues. It is over the counter and easily used and can be used for cognitive dysfunction conditions like Parkinson’s

and Alzheimer's and also Traumatic Brain Injury and Havana Syndrome Brainfog. It has been useful to dissolve the plastics which are these polyamides proteins. Helpful Brain Peptides Currently Banned by the FDA but are still available on some websites:

Dihexa — 10 million times more potent than brain derived nerve growth factor. You can regrow neurons.

Selank — decreases neuroinflammation, promotes neurogenesis, blocks anxiety and depression  
Deep Delta Sleep Inducing Peptide — reverses chemobrain, similar to Traumatic Brain Injury from microwave damage  
Epithalon — reversed radiation damage and accelerated aging  
GHK Copper Peptide — increases neuron gene transcription  
500–800% BPC 157 — used for reversal of Traumatic Brain Injury [1:24]

Sarah: How common is the graphene and all these things in the vials?

Dr. Ana: We found no mRNA in the shots but we found metals and when they were self assembling the polymers, polyethylene glycol is actually part of a hydrogel that can self assemble and actually create biosensors. So with regards to the mRNA we are not certain how many got the reverse transcription but it appears that what we are seeing is the technology that was installed and that is shedding and we found this in the meat supply. We found this in the masks. We found it on the PCR swabs. It's being sprayed by geoengineering. So we are being bombarded by it, and basically everyone has this now in their blood.

Sarah: So the delivery mechanism isn't just the mRNA vaccine. It's the nano dust. It's our food supply. It's everywhere.

Dr. Ana: Absolutely, and they were saying in 2013 that they had placed nanotechnology in the municipal water supply and in Coca Cola and Dasani water and that 89 percent of Americans were already affected with dormant nanotechnology that could be remotely activated with a drone and frequency that would cause an illness that would kill people in 10 days. So nanotechnology has been around for 30 years.

Sarah: So when you do this research you are researching vaccinated and unvaccinated and you are seeing the same stuff in both?

Dr. Ana: Yes. This is why people need to start talking about self-assembling and self-spreading technology. Because if you don't know about it, and don't know how to decontaminate from it, then a lot more people are going to be ill.

Sarah: I have seen studies about self-disseminating vaccines for over a decade. Is this beyond that, where they vaccinate a host rabbit and it vaccinates everyone around it. I think they were around 70 percent effective. Is the shedding enough to get these self-assembling nanobots into our body? Or does it just help with the smart dust and crap that we've been subjected with?

Dr. Ana: I believe that it helps with everything because really what their transhuman agenda is, is that they want to create a fusion between every organic cell and synthetic biology because they don't want anything natural or of God to continue to exist on planet Earth. So it is not just creating human cyborgs now, but it is affecting all of nature. Every microbe will digitized, genetically modified, and engineered until the entire biosphere is no longer the original creation of God.

Sarah: Do you have the information somewhere where people can find it and learn how to get this out of their blood?

Dr. Ana: Yes. I have all that documented.

In 2021 the Journal of Special Operations Medicine came up with the term UBI (Unconventionally-Acquired Brain Injury) a condition that only people in the military can get, but civilians can't get because the government does not recognize it. A UBI could be compared to placing an egg (your brain) into a microwave which could induce extensive damage. So the military knows about the Directed Energy Brain Injury.

So after seven years they came up with the consensus that it is Nonkinetic Brain Injury. Nonkinetic means nothing is moving besides the energy and the energy is damaging the brain. Non-Kinetic Brain Injury (NKBI) or repeated Non-Kinetic Brain Injury (rNKBI) is not in the ICD-10 medical coding classification of diseases other than as "Brain Injury,

Other” (S06.9X0A). I have gone on disability even though the government does not recognize it. I am on disability with recurring Nonkinetic Brain Injury (rNKBI).

Myth 2. It is a Mass Psychogenic Illness (MPI) or mass hysteria or connected to sound of crickets. This hypothesis was rejected in 2022 by NAS 2019 and IC reports on MPI. Biomarkers associated with mTBI (Mild Traumatic Brain Injury) and concussion, called neurofilament light chain protein (NfL), and glial fibrillary acidic protein (GFAP) are elevated in patients with AHI. Levels return to normal within a few weeks, which matches the time course after concussion, indicating damage to the Blood Brain Barrier (BBB) and neural injury. The fact that these biomarkers of concussion are elevated and then they subside just like in a concussion invalidates the MPI hypotheses that you can't make your biomarkers go up just because you believe that somebody is hitting you with directed energy.

For those who are not familiar with the report I shared on AHI (Anomalous Health Incidents), Analysis of Potential Casual Mechanisms, IC Experts Panel obtained in March 2023 via FOIA request by The Madison Project for a lawsuit, the potential causes of these symptoms, the biomarkers, were obtained from that report, both highly reactive and also informative.

Myth 3. The symptoms are general and non-specific. We heard it all. It is just a headache. This is CIA agents having a hangover. The same report says that although some signs and symptoms of AHIs are common in known medical conditions, the combination of the four core characteristics is distinctly unusual, is unreported elsewhere in the medical

literature and so far has not been associated with a specific neurological abnormality. So although the symptoms might look like general symptoms, together they are not and never seen before by a neurologist.

Four Core Characteristics that occur together:

- a. Acute onset of audio-vestibular sensory phenomena, including sound and/or pressure in just one ear or side of the head.
- b. Other nearly simultaneous signs and symptoms such as vertigo, loss of balance and ear pain.
- c. A strong sense of locality or directionality. You can feel where it is coming from.
- d. The absence of known environmental or medical conditions that could have caused the reported signs and symptoms.

However there is not a medical condition in which these four signs occur together.

Myth 4. Doctors don't know how to diagnose it.

In 2018 Dr. Hoffer's "Acquired Neurosensory Dysfunction" lays out initial diagnostic criteria based on the 25 people who came from Havana.

There is an additional Hoffer/Balaban paper on using computerized tests. You can actually differentiate between brain injury from directed energy in the Havana Cohort and concussion using an objective computerized oculomotor test.

In 2021 the Havana Act was signed into law stating a penetrating brain injury, as opposed to directed energy brain injury, and persistent disabling neurologic symptoms can be diagnosed by a board certified neurologist. IC Report contains most recent diagnostic criteria recommendations.



One of the methods in the Havana Act that doctors can use to diagnose penetrating (directed energy) brain injury is an electroencephalogram, EEG, but a regular EEG will not give you the type of information that you need.

However a quantitative electroencephalogram (qEEG) with swLORETA, a computer package, can see neural nodes within the brain and show occasional abnormal neural connections. Pictures from a qEEG show dark blue lines which is a Delta speed connection (0-4 Hz) between the neural nodes. The Delta speed is only supposed to happen during sleep or in a hypnotic state. I am operating on this brain and it takes a lot of effort to sound normal. To connect the dots and bring it together in one diagnosis doctors need to record energy exposure while the patient is undergoing a NeuroStrike Attack, and that information is classified by the government as secret and does not want doctors to diagnose rNKBI (recurrent Non-Kinetic Brain Injury) with utmost certainty.

Myth 5. Civilians do not suffer from it, only diplomats and spies in foreign lands.

Dr. Giodano, a neuropathologist at Georgetown University in D.C. said at the medical conference in 2022 dedicated to Havana Syndrome that civilians suffer from Havana Syndrome also and investigation of Havana Syndrome is ongoing. What has become clear from investigations to date is that current and emerging biotechnologies such as NKBI directed energy systems pose significant risk and threat to public safety and national security.

Myth 6. We'll get to the bottom of this!

Government officials like Anthony Blinken, William Burns, and Christopher Wray repeated this statement numerous times but nothing happened. If a targeted individual complains to the FBI and that is the right agency to investigate it because it is happening domestically, and if your Congressman finds a way to file an inquiry, this is what the FBI response is: In order for the FBI to initiate an investigation of any complaint we receive, specific facts must be present to indicate that a violation of federal law within our investigative jurisdiction has occurred. Based on the information provided, we are unable to identify any violation of federal law within the investigative jurisdiction of the FBI. We are, therefore, unable to be of assistance. If you ask the FBI what needs to be presented they don't answer that question.

Myth 7. We don't know anything about weapon systems causing "Havana Syndrome."

However, there is a Directed Energy Weapon Systems Acquisition Act of 2016 that was read on the Senate floor and the House of Representatives and passed on to the US Army Commission and it contains a definition.

"Directed energy weapons system" means military action using highly focused sound, electromagnetic, or particle-beam energy to incapacitate, damage, or destroy enemy equipment, facilities, or personnel.

Incapacitate personnel, that is what DEW systems do, but we don't know anything about it. In a 2023 podcast "The Sound: Mystery of Havana Syndrome" by Project Brazen, Episode 5 the host ask Dr. Giordano is there a type of weapon out there that can cause the specific symptom profile that the victims in Havana experiences? That means something capable of not just causing problems, even brain

damage and all that, but also do it in this precisely targeted way? and Dr. Giordano's answer was "YES!"

Sarah: How widespread is the use of this technology?

Len: All over the world, if you count civilians, every country, but the government only talks about diplomats and spies that it has happened to them in maybe 20 countries, but we know through the Targeted Justice Questionnaire it is worldwide, and there is nowhere to hide. You can shield yourself from the regular energy with a Faraday cage but there is no way to hide from the longitudinal waves.

Dr. Ana: I want to introduce Ana Toledo, J.D. who has been fighting for Targeted Justice and she is a targeted individual for more than 20 years.

ANA TOLEDO

Ana: Thank you for having me here. It is so important that people wake up about what the targeting program is all about. The "Program" as it is referred to is a targeted individual program from a legal perspective. [2:04]

Paula: One option is you can go to Patient Advocate Bulldog. They have a JAB rescue kit. We will get Dr. Ana's information as well.

Dr. Ana: We have Dr. Len Ber an endocrinologist who has also done research on the nano technology and he is also the first US citizen to be on disability for Havana Syndrome.

LEN BER, MD

Len: There is so much malinformation about Havana Syndrome. We owe the term "Havana Syndrome" to Dr. Ludwig De Braeckeleer. I found ten myths about Havana Syndrome.

Myth 1. It's called AHI (Anomalous Health Incidents). It is not a medical diagnosis. It is a misstep. It is not a disease. Robert McCreight called the symptoms of Havana Syndrome NeuroStrike. A neurostrike weapon is a platform mounted or aerial mounted of radio frequency directed energy neurocognitive disruptor which is designed to harm, disable or permanently damage a human brain. Dr. Ana: I want to introduce Ana Toledo, J.D. who has been fighting for Targeted Justice and she is a targeted individual for more than 20 years.

ANA TOLEDO

Ana: Thank you for having me here. It is so important that people wake up about what the targeting program is all about.

Dr. Ana: And you have a presentation on the legal avenues, so please proceed. [2:04]

Ana: The “Program,” a legal perspective as it’s referred to the Targeted Individual Program is one of those special access projects that is funded by Congress with taxpayer money and it is a silent holocaust occurring, not only here in the United States, but also around the world and it is being carried out by the United States agencies, the CIA, the United States Space Force, the FBI and the DHS among others.

Ana L. Toldeo, Esq., is originally from Puerto Rico and is admitted there in the Supreme Court, also admitted to the Puerto Rico US District Court for the Districts of Puerto Rico and Southern District of Texas, First and Fifth Circuit Court of Appeals.

I went back to Puerto Rico to try to clean things up after the mess had been left behind by the Section 936 the industrial boom in Puerto Rico and I became targeted.

The Program’s global scope aims to control and destroy opposition and its predecessors are the CIA who sponsored the MK-ULTRA program from 1953 to 1966 to control human behavior by developing brainwashing/interrogation techniques. The tactics were atrocious. During 1975-76 the Church Committee investigated and supposedly shut it down. IT NEVER SHUT DOWN.

The FBI had its own atrocious program as well from 1956 to 1971, the Cointelpro Program aimed at surveilling, infiltrating, discrediting, and disrupting domestic American political organizations. The FBI's program did tremendous destruction to many people, to the country, and certainly to the FBI. 74,000 Puerto Ricans were the victims of this. Anybody who was pro-independence was persecuted, surveyed, and it was a stasi state. The former director of the FBI, Mr. Louis Freeh admitted that the FBI did operate a program that did tremendous destruction to many people. They vowed not to do it again but here we are with a targeted individual program. We know this program never stopped because paperwork shows that 19 percent of the TIs were targeted before 2003 and 36 percent only were targeted between 2004–2017.

The 19 percent means they are the remnants of the MK-Ultra and Cointelpro programs that never shut down, and the reason they never shut down is because no one was held accountable. No one went to jail despite the documented atrocities that were carried out and perpetrated upon innocent Americans and people around the world.

Today's human experimentation roster is listed individuals on a secret category in the carrier screening database that started operating since 2004. The Homeland Security Presidential Directive 6 which was enacted and authorized by President Bush in 2003 is not an act of Congress. It is an egregious abuse of the administrative state because it was originally designed to contain the names of known and suspected terrorists. This was following 9/11 and it was to protect our nation. So it was authorized with that justification

of the terrorist attacks and it consolidated 14 different terrorist lists maintained by different agencies.

The Watchlist started operating in 2004 under the terrorist screening center which is a division of the FBI, so what happens is that there has been a lot of litigation by the Muslim community against what is called the Watchlist which is composed of codes one and two that are the two sublists of the categories of the terrorist screening database that supposedly contain the names that are the known and suspected terrorists. Their lives are destroyed in so many ways, but those are the people who have challenged so far the terrorist screening database. In 2019 a statement under penalty of perjury by Mr. Timothy Groh, former Terrorist Screening Center Deputy Director admitted that what we hear talk about all the time, the Watchlist only contains the information of those handling codes one that are the known and suspected terrorists. [2:10] Under penalty of perjury, Mr. Groh admitted on behalf of the FBI that they have innocent people identifying information of individuals that are not categorized as known or suspected terrorists. He explains that these limited exceptions to the reasonable suspicion standard, which is what they're supposed to meet a little initial and below probable cause to be placed on the list. So these people are placed on the list for the sole purpose for supporting criteria, special screening functions of DHS and State supposedly. Since these people do not represent a threat to national security they are never screened at airports as such. However, we now know the reason why they are not screened as terrorists even though they are included in the terrorist screening database is because they

were never supposed to find out. The people in handling codes three and four are the secret categories of a terrorist screening database of innocent Americans and civilians around the world placed on this list for human experimentation purposes that are a combination of a continuing of the MK-Ultra and the Cointelpro. The reason we know this is because Mr. Groh admitted under penalty of perjury that only handling codes one and two constitute the watchlist of known and suspected terrorists. We estimate today there are around 400,000 targeted individuals in the United States which are the listed individuals non-investigative subjects in handling codes three and four. The Office of Inspector General in one of their reports OA-16 audit reports of the terrorist screening centers stated that the FBI nominates people to directly to the TSDB in violation of their own regulations FBI field offices. We estimate there are 6 million around the world. Seventy-five percent of the people on this list on the handling codes three and four, those on list four don't know they are targeted because the targeting is very slight. You might wake up in the morning and not feel like yourself but you attribute it to aging, but it is not aging. It is using the microwave throughout the night.

The people in the handling codes of three and four even though they are not screened as terrorists at airports, they are labeled as suspected terrorists to the entire nation. The list is distributed through the National Crime Information Network Center which also distributes the list of the violent gang members, and sex offenders, so for all practical purposes around 400,000 innocent Americans are labeled as suspected terrorists and circulated to 18,000 law enforcement agencies, state, private, and federal, 532

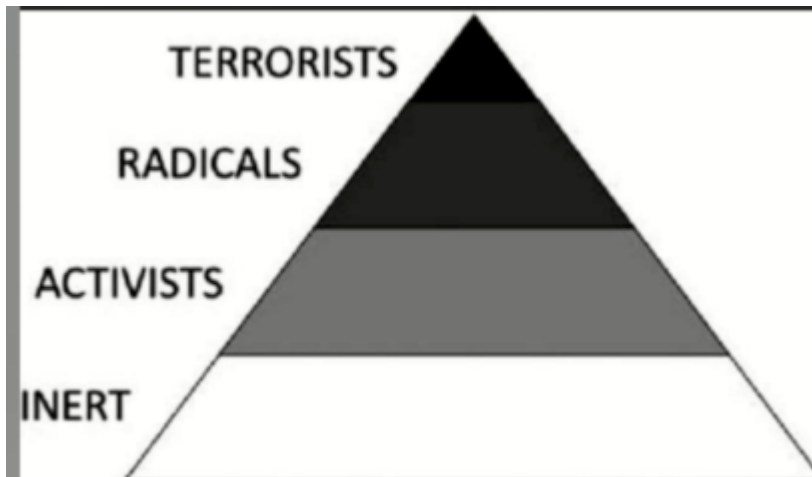


corporations and 1,440 organizations such as universities as well as 60 countries. This is why a targeted individual may want to go sometime and wire money to a relative and they will not be allowed to or they will have their bank accounts closed.

The transformation of the US into a Stasi state. Money makes the world go round and that is exactly what is happening here. The United States government is making our brothers and sisters turn against targeted individuals just for money. Financial incentives to private corporations to find targets, delegating “intelligence” for financial gain. You can do a job search for “Targeting Officer” and hundreds will come out and the United States agencies are delegating, the FBI, they are delegating. The law enforcement lacks intelligence of American federal agents to private corporations that have a financial incentive. The more people they put into the list the more they get paid. This is where we have to connect the dots of what the whistleblower Steve Friend has been talking about, about how the FBI agents are pressured to label as domestic terrorists people who do not meet the reasonable suspicion criteria. This is what we are talking about. They are being put in subcategories three and four of the terrorist training database for the human experimentation program.

The DHS is giving grants away to corporations under the Targeted Violence and Terrorism Prevention Grant Program. The pyramid you see is how they categorize the target.

1. Inert, people who stay home,
2. Activists,
3. Radicals,
4. Terrorists



The pyramid above shows the participants of the Far-Right Radicalization, which is pretty much specifying them as terrorists and so you can identify Heritage Foundation, Fox News, Prager U among others, so these people got 342,000 dollars for this seminar and the DHS is throwing money around to private organizations to choose, survey, stalk, harass, label people who just think differently or they just

have a different point of view at terrorists and to be martyred alive from society. [2:17:21]

How come no one has shut it down yet?

This has been operating at least since 2004 under the Terrorist Screening Database. One of the things I discovered by doing random searches on organized stalking, gang stalking, microwave weapons, V2K is that there are common denominators. Most of them are pro se plaintiffs because the victims cannot afford an attorney or the attorneys are scared, intimidated or black mailed and won't file a case on behalf of targeted individuals. Many of them are dismissed on unpublished opinions so the general public would not have access to them unless you have access to the very expensive legal research services. Our statistics tell us that 14 percent of targeted individuals are homeless versus the national average of 25 percent. So by filing in forma pauperis because they don't have money for the filing fee, they are subjected to more strict screening of their complaints. Many are dismissed without defendants even have to answer.

The common language of hundreds of federal court opinions

“Fantastical, delusional, implausible, bizarre, haphazard and disconnected allegations are baseless, irrational, and wholly incredible.” This is the common thread of all dismissed cases I have seen involving targeted individuals. And while it is true that some of them might sound fantastical for targeted individuals, I mean as a targeted individual I know children as young as three years old who are being tortured with V2K (Voice to Skull) which is a microwave auditory effect. It is real and it is a pattern set technology and it has

been admitted by the armed forces that they use this technology. The most interesting thing about all of this is despite all the fantastical words used in these lawsuits not a single one has entailed sanctions after filing a frivolous case. Nobody bats an eye that over 300 of these cases have been filed. Somebody should be looking at this.

TJ v. Garland is the lawsuit we filed last year and we were asking for declaratory judgment and to the elimination of handling Codes 3 and 4 and removal of the terrorist screen database that we know includes people that do not represent terrorist threat and that we know is a roster for the targeting program. We also sought damages and Bivens remedy against individuals who had official capacity because they know they are placing innocent Americans on this list knowing that they don't meet the original suspicion standard

This case is based primarily on admission by the government, by the FBI, United States of Adjustment Audit Report, United States Office of Inspector General Audit Report, so you can say 80 percent of the lawsuit is based on uncontroverted governmental admitted facts. They have also admitted that they put people on this category under secret criteria. It is curious that we filed on January 11, 2023, and by the end of that month the 6-year Terrorist Screening Center Director, Charles Kable, retired. Pursuant to TJ statistics of almost 2,000 targeted individuals that have replied to a questionnaire that we did, 43 percent of them

have been targeted since 2017 on when Mr. Kable started tenure at the Terrorist Screening Center. That is huge because when you consider that out of the 57 percent, 19 percent say they were targeted before 2004, before the Terrorist Screening Database was entered into effect. What we are seeing here is that at least 36 percent really were between 2004–2017, and 43 percent were targeted after Mr. Kable began to direct the Terrorist Screening Center. People who were placed on the list without meeting reasonable suspicion criteria.

Our ultimate goal: No names, no targets. If we eliminate Codes 3 and 4, the US Space Force and the CIA don't have targets against whom they can aim their directed energy weapons and their torture and the same goes for DHS who deploy people who go harass, stalk, and do the surveillance on innocent Americans without validity, Article 3, Issue 1.

Looking forward, what comes next? I am hopeful that we are going to shut down this program, and the reason why I know it is first of all we have an appeal pending in the 5th Circuit which is known to be a very constitutional respecting tribunal. We don't have the date announced yet, but as soon as we have it we will be announcing it everywhere. There is an oral argument also pending in the 5th Circuit for March, 2024 in the case Kovac versus Wray. That case is a challenge to the Watchlist, and the important part here is that they are challenging the state. The major question is that the Homeland Security Presidential Directive that created the Terror Screening Database is not an act of Congress, and inasmuch as it affects so many aspects of a person's life, it should be an Act of Congress. That is one of the things pending. Another one is FBI versus Fikre which

was argued, the oral argument was January 8. This man, this plaintiff has a due process right to explore why he was put on the Watchlist and controversial evidence and the case is not moved just because you removed him from the Watchlist. It is not moved. The other important event happening is the Peters' Intelligence Committee investigation on "Mislabeled as a Threat." Also, there are 20 Senators who are investigating the abuse of the Watchlist, and they send a letter to all the agencies involved and so that is something we have to be following up on and finally the Khairullah versus Garland case was filed in the United States District Court for the District of Massachusetts through a mayor in New Jersey, and for 18 years he has been a mayor and he was placed on the Watchlist. So the future is bright and hopeful for freedom of Targeted Individuals I hope comes very soon.

Sarah: Do these Targeted Individuals realize that they are the lab rats for this entire program we have been talking about, mind control, COVID, everything? These individuals are their lab rats that is allowing them to build these programs. Is that awareness coming?

Ana: Well as I mentioned, only 25 percent of Targeted Individuals know they are targeted because when they bump them up from tentacles four to three, that's when their V2K started or their really bad microwaving. So that's when they realized, "Oh my God something is happening." I do want to mention the megaphone test for targeted individuals and yes, we are aware we are guinea pigs, a terrible experiment. PETA was able to stop the armed forces using directed energy weapons experimentation on ferrets. Now we are asking they do the same for our pets, because it not

just targeted individuals, their children and their pets are also targeted and it is a silent holocaust happening in America and around the world.

Sarah: Where can people learn more about what you do and where can they find you?

Ana: [targetedjustice.com](http://targetedjustice.com) I am a member of the advisory board. Just follow what is going on in the 5th Circuit because this program is going to be rolled out to the rest of the population through the self assembly chips and vaccines and dental anesthesia. If some people just voice their opinions they will be categorized as a domestic terrorist and targeted.

Dr. Ana: We can't wait to hear your perspective. You have been a real insider. Please Major, enlighten us to what your perspective is. [2:33]

JEFFREY PRATHER, Major, US Army (Ret)

Jeffrey: The US Air Force Directed Energy Directorate Center is on Maui. I broke a story about how the directed energy weapons came from the Chinese satellites there as well. Also the FBI is not, and I graduated from the FBI Academy in 1990, the FBI is not a law enforcement organization. It is an Intelligence Agency with law enforcement functions. I just had FBI whistleblower Garret O'Boyle on my show talking about that as well.

Where I first experienced this, if you can put up the first slide there, is... Of course most people now know I was a Fast and Furious whistleblower. I exposed the DEA deal with a

cartel to run drugs north in exchange for the Fast and Furious guns going south. I was 45 minutes away from Brian Terry who was murdered in the canyon. But something that puzzled me at the time was I was designated as a prime target by the DEA. I didn't understand that. They accused me of outside employment. They accused me of being a rapist. They accused me of being an occult leader. I was never charged. I was never convicted of anything. It is something they just pull out. They do it against Flynn. They do it against Trump. They do it against everybody. I didn't understand the designation because under the drug enforcement administration I was a DEA Special Agent for 19 years until I was fired one year from retirement without being charged without ever of having a bad evaluation.[2:35:17]

We only have one narrow US Code, 21 U.S. § 841 A1, which is possession with intention to distribute. I did lots of big drug cases, 2,000 pounds of cocaine, 4,000 pounds of marijuana, 10,000 pounds of marijuana, but I never understood until I got involved with the Targeted Justice movement how they could designate me as a prime target because they never accused me of selling drugs and that is the only thing the DEA has authority for. Now it starts to make sense if you go to the next slide, prior to the DEA I was serving with Special Forces Group and before that an Operations Group throughout Central and South America in the '80s working with the Contras and I saw close up how the CIA started running cocaine to support the Contras which then built a cartel of death. Then I saw the switchover when I went over into law enforcement to the DEA because



CIA had been running the cocaine into black neighborhoods making crack, we used to make crack, so I have seen close up the unholy alliance between the military, between the intelligence community, and between the law enforcement community and how that has evolved. [2:36:49]

This is nothing new. The British did it. They forced China open so they could sell the population opium. And that's what the DEA did with the similar cartel. And that's what the CIA was doing with cocaine. So it is biotech. It is big pharma. And so that's also what's happening as they push fake viruses and fake COVID, which was like the flu, even though it was modified by the furin cleavage.

What's fascinating about that is the next slide is what I knew about but has since come out, from unclassified sources is the DEA had a special unit called SOD (Special Operations Division). They still do, a Special Operations Division. It started as a title three wiretap of Colombian cartel leaders calling the United States. They couldn't afford it. They handed it off to the CIA. It doesn't say that here, but that's the case because I had top secret clearances with the DIA and with the DEA simultaneously DOD and DOJ, and so they were monitoring these calls. But you had to do what was called minimizations. If they weren't talking about something bad, you had to stop listening if it wasn't related to drugs. But SOD is at a secret location in D.C., and on one side sits everybody from the intelligence community, and I was an army military intelligence officer. I was with the Defense Intelligence Agency as well. And so you've got CIA, NSA, DHS, NRO, national reconnaissance, all of these guys collecting SIGINT, signals intelligence, OCONUS outside the

Continental United States, and then bringing that intelligence in. And on the other side of the room, sits FBI, DEA, border patrol, marshals, everybody else. They hand that signals intelligence, classified intelligence over to the law enforcement folks and say, now you can't say where you've got this because you always wanna protect sources and methods, so you have to develop your own parallel probable cause. And Ana addressed this to a degree. That is clearly fruit of the poisonous tree under a legal term of art. And so it is completely false, and it is represented very much by my career having experienced it firsthand because the DEA wasn't interested in stopping drugs. The DEA was interested in getting more money, building a power base, the same thing that the FBI is doing.

They are in essence, the modern praetorian guards of what was the praetorian guards were of the Roman state. They controlled who was emperor, the FBI, CIA that is the federal law enforcement and the federal intelligence community now control the federal government to their end. So Len Ber is not going to get any answer from the FBI. They're not interested in that at all. They're interested in election control. And again, this goes back to the surveillance aspect, but once you start getting, imbibing all the nanoparticles and Dr. Ana was talking about this in great detail, it's much easier to track everybody and with V2K, to plant suggestions. I believe that's what's happening with all the transgender shooters. They're all very common. Like that, they all play gaming, violent games. And so they can manage all of that and control all of that to a greater degree. And because everybody has these devices now, they can really manipulate everything through that.[2:40:57]

Biden has just come out with a Secret Surveillance Court, and I think this is the other end of the SOD, which is still operating. There is now a Secret Surveillance Court because we've seen the FBI, Pfizer abuses. Fifteen years ago when I was saying Eric Holder's line, the DOJ's line, the DEA's changing reports about me, but now with client's nephew has struck with all the revelations. Everybody is very clear on this. And so the answer to that now is to make a star chamber court for the SOD for the biodigital surveillance mechanisms to keep it all classified. And this goes right into the terrorism database watchlist as well.

And by the way, I had Sasha Latypova on my show a while back and she showed how I was on there, but they had my name as Jeremy Prather instead of Jeffrey Prather. Funnily enough it was at 3100 Clarendon Avenue which was the DIAs Global Watch Center. I ran it and, even having been in all their databases, they couldn't even get my name right. So they're not giants nor geniuses. They are just mostly failures with father wounds. You should not be afraid of them. But you should understand what they are doing, and these massive surveillance that started out with tighter three wiretaps is now continuing in my view, through all of this biodigital engineered surveillance, which is in the water, which is in the air as well.

And this court is secret. There are eight judges that Merrick Garland has picked and they have deep rated classified information experience. There's the NSA. There's the National Security Council, which is the president's Star Chamber Council and the Department of Justice is in on this, but nobody is going to know if they are under this because it's all classified. That's the great thing about

classifying stuff is they won't tell you that you are on any of this. So this is, I believe, the next counter to what Targeted Justice and Ana Toledo and everyone else is trying to bring about is to make a secret star chamber court that no one ever knows about after they have had significant OCONUS intelligence passed to CONUS law enforcement to be used against you as well. And this I think is how I ended up as a target.[2:43:41]

To answer the moderator's question there, I never thought of myself as a targeted individual. I had several of them on my podcast. But now as I look back I can see how they talk to my ex-wife. They talk to my kids. They influenced everybody. Now that was 15 years ago. It wasn't sophisticated as it is now but that ties into why everybody is so fascinated with having mRNA and genetic modifications in all of the latest bioweapons that are not vaccines, but that masquerade as vaccines, and HR 3832 just came out, and this is a bill for countermeasures for disease X, and this was in October of 2023, and so this has become a great resource for them just as the DEA made a deal with the Sinaloa Cartel to run drugs north in exchange for the Fast and Furious guns going south and the dissimilar cartel would tell on the other cartels so the DEA gets stats while the DEA helps Sinaloa Cartel run drugs and the ATF run drugs south.

The FBI ran the hitters that hit the border patrolman, Brian Terry. It's now just evolved in my view to a much more sophisticated level because the global... back then we had the Motorola brick phones. They didn't work so well. Now you can get all of this bio information and not so much listening to what everybody says. A person isn't monitoring that Title 3. It's data mined by NSA AI looking for patterns,

but this new secret court will close the loop so that this stays secret, and this is the New Data Protection Review Court, and so this will solve even though Congress has allowed the FBI to have a new headquarters bigger than the Pentagon. They've forgotten about all the FISA (Foreign Intelligence Surveillance Act) abuses.

This is another total level of secrecy that we are really going to have to become aware of, and as I interview my peerage who are former special operators, former special agents, all these law enforcement, and military organizations that I was part of are now hollow shells, and they are just filled with incompetence. The FBI, the military is not going to require high school diplomas anymore. And the DEA back in my day I was a snowcap special operator. That's gone. That was a special program where we worked with host nations, military and police for counter drug operations, primarily cocaine. Regional and force teams are gone. High risk entry teams are gone. The foreign area support teams are gone, and the reason is because they aren't really interested in any enforcement. They are interested in control and all aspects of federal law enforcement and military have been designated as such for that purpose.

That's where all this is going, so I think it is really important that Targeted Justice stands up and makes progress. The 5th Circuit has come up with some really great decisions recently as a disabled vet. They just defeated the AR pistol proposition. So I do agree with Ana that there's a lot of hope for this and I am always faith-filled as well, and of course the ultimate role of this is to control everyone. So the World Economic Forum wants to control everyone for their purposes which is Communism. China, which is already

fading, wants to control them to keep all the goods flowing, but ultimately as a Christian, I see this as an adversarial targeting to modify the land of Penueel, where Jacob wrestled with the angel so that the word of God is no longer clear or heard.

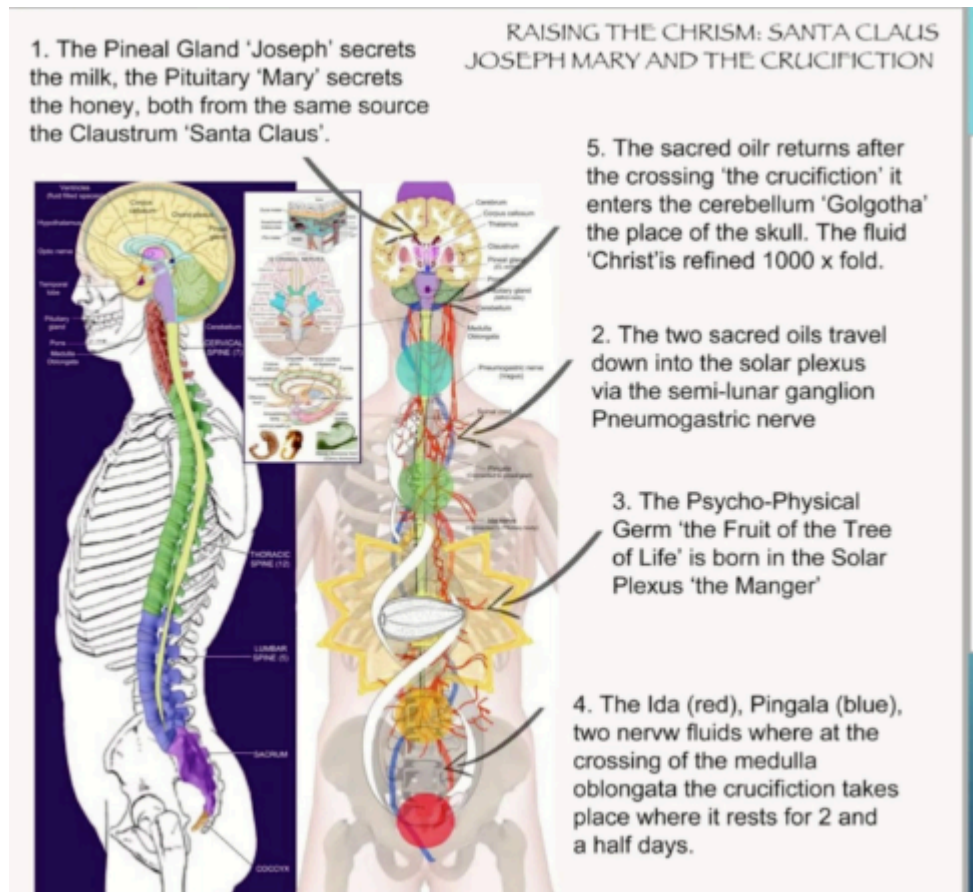

People have been talking about grounding, about charcoal, about EDTA. But really as a long time martial artist and a Christian this really goes back to the Kingdom of God being within you.

Jeffrey: Well there's Todd, and Todd had me on a FAA whistleblower conference awhile back and credited me with helping with that. So 50 years ago there were very few whistleblowers. Now I'm very heartened to see IRS and FBI coming out all over the place and a lot more resistance. But those that are still inside, it's a pretty corrupt... it's not like the politicians say, it is just the guys at the top. It's pretty corrupt all the way through because those in there no longer



have a generic native Christian ethics, which is the base for our morals, which form the basis for our great love of life and freedom, but they aren't particularly effective. You don't need to be afraid of them. You need to be wary of them. But they are failing and they will fail. They're like the characters in CS Lewis' "Screwtape Letters."

Sarah: Because it's imploding on itself, right? They are not as clever as they think they are.

Jeffrey: No they are self extinguishing themselves. It's like David when Goliath says why are you coming with your staff. Well, he's got his shepherd staff, which is not a handsling. It is a staff with a sling on the end. It's like a handheld trebuchet. And David says, "Hey, I've killed bears and lions. I can do you too." And he does. Low Tech, you know, we can win this.
